SCC Chairperson Annual Report – Nov. 2, 2022:

- After the Annual Mtg Last year, I was appointed Chairperson of the CJES SCC. I was fortunate to have Taunya as Vice-Chair and Brandi as Treasurer, and Lauren as a Parent Rep. We did have members that helped even though they weren’t one of the 5 voting members (thanks Lindsey Propp, Jill Craig and Jocelyn Maddaford-Collingridge). Our Grade 4 Reps were Chance Weinbender and Rachel Mentanko. Thank you to all the members for being part of the SCC and doing what we could to enhance the learning experience for CJES students.

Here are some things we were able to accomplish:

- The CJES SCC approved the 2021-2022 LIP and Budget.
- The CJES SCC made a motion to support an outdoor classroom on the CJES playground. The project would move forward with the work of the CJES staff and the SCC will be kept in the loop about progress.
- The CJES SCC contributed \$100 towards the “Dancing Horse” presentation that took place at CJES.
- The SCC made a motion at the November meeting to purchase 7 ipads for CJES students. This was an over \$3000 commitment.
- Our SCC Student Reps were able to organize a Christmas movie. Snacks were also provided for the movie
- The SCC made treat bags for the entire school, they were given out at the Christmas movie.
- The 2 SCC 50/50 Fundraiser raised \$4072.50

- After hearing that 22 Chromebooks would be outdated that following year, the CJES SCC made a motion to purchase \$7000 worth of Chromebooks and contribute to a 1:1 student: device goal. Brandi and her husband also contributed another \$1000 from their personal company.
- For Teacher Appreciation Week in February, each staff member received a \$15 gift card to the COOP from the SCC.
- Sub sales were re-introduced into the school after not being able to do if for some time due to Covid.
- Purdy's Chocolates were a CJES SCC fundraiser that cleared just over \$500
- The CJES SCC Student Reps presented a Thank-you card to the Crossroads Credit Union for their kind donation towards 1:1 devices.
- The SCC was able to support the Grade 4's Farewell. A \$7 Credit was given to each Grade 4 at the Canora Dairy Bar.
- The CJES SCC hired a CCS student to look after our Garden during the summer. Thank-you Mrs. Prychak for your work getting funding for this.
- Many of the CJES SCC members were able to volunteer for Playday, another event that wasn't able to happen for some time due to Covid.
- The SCC approved the Terry Fox fundraiser which Mrs. Prychak can update us on.
